MDsuite provides the basic functionality for providing educational information based on the data collected and recorded in the chart. Annual licensing and subscription fee included in base service agreement.</p>	<p>Annual licensing and subscription fee included in base service agreement. Additional fees may apply if customer needs assistance with a third party educational resource for inclusion into the record.</p>	<p>Base licensing and subscription fee includes the ability to generate the patient educational information based on patient's problem list, medication list, and laboratory tests and results. Services such as ExitCare are products that integrate with MDsuite, but are contracted separately at an additional cost. Customers are given 5 user licenses per provider license for usage. <p>Electronic prescribing. (Relevant certification criteria: 170.315.b.3)</p>	<p>This functionality allows the user to electronically prescribe medications for their patients.</p>	<p>Annual licensing and subscription fee included in base service agreement. The ability to electronically prescribe controlled substances requires an additional subscription fee.</p>	<p>Base licensing and subscription fee includes the ability to submit electronic prescriptions to pharmacies of the patients choice. Additional contracting is required if the practice wishes to also prescribe controlled substances. Customers are given 5 user licenses per provider license for usage. These changes vary from agency/registry and are priced according to the requirements.</p>	<p>Base licensing and subscription fee includes the ability to create a file for use by public health agency/registry. Direct messages may include clinical data, notes, and other information, subject to the limitations noted. Our Direct offerings support related Meaningful Use and ONC requirements for sending and receiving transitions of care summary documents. We also support a range of other messaging options. Our Direct capabilities include bundled Health Internet Service Provider (HISP) services for facilitating message exchange.</p>	<p>Annual licensing and subscription fee included in base service agreement.</p>	<p>The Direct messaging capability is restricted and users will be unable to exchange messages with users of third-party HISPs with whom MDsuite does not have a trust agreement. At the present time this is limited through the use of Updax listed as our Direct messaging vendor. All Direct messages both in bound and out bound, will automatically pass through Updax as part of our standard product. Other third party HISPs are not available at this time.</p>	<p>None</p>
